Minutes of February RMGC Board Meeting for Review/Approval

REPORTS OF OFFICERS

PRESIDENT IACULLO

President lacullo announced that 112 members were signed up for the Spring Meeting scheduled for 5:00 PM in the event center. Menu to include pizza, chicken wings, and a taco bar, as well as an open bar. The speaker will be a USGA rules official who will discuss the recent USGA rule changes. In addition, Mark Heptig will discuss recent and planned changes to the Rossmoor courses.

lacullo reported that the Sponsor Committee met and established 3 levels of sponsorship for Rossmoor golf events: Platinum @ \$3,000, Gold @ 1,500 and Silver @ \$750. The Board discussed possible businesses that might be interested in sponsoring an event.

Reestablishment of The Hawaii Dinner was discussed by the Board and approved by acclamation.

PRESIDENT ELECT/TOURNAMENT ATKINS/SNYDER

Atkins and Snyder discussed the need for a local rule for drives that go out of bounds, consistent with recent USGA rule changes. The proposed rule states that "a ball that goes out of bounds and is lost may be replaced by dropping the ball in the fairway at the point the ball went out of bounds with a 2 strike penalty." This rule replaces the requirement that the golfer must return to the tee and hit the drive again with a one stroke penalty. Extensive discussion ensued. Atkins called the vote and the proposed local rule was approved.

Tournament fees will increase by \$1.00 this year. In addition, member-guest tournament play will be gender-free.
