MINUTES OF THE PREVIOUS MEETING

Minutes were approved as distributed.

REPORTS OF THE OFFICERS

A. PRESIDENT NITTA

- 1. Hawaiian Night ended up with loss of \$322.64. This was primarily due to complimentary meals for bartenders, band members and technicians.
- 2. Committee has met regarding November Annual meeting and has come up with the following:
 - a. Last year only 73 attendees. Dinner cost was \$35. Charged members \$20 and club subsidized \$15.
 - b. Goal is to increase attendance.
 - c. Guest speakers Tim O'Keefe and Mark Heptig.
 - d. Curtis will be presenting awards for various tournaments.
 - e. This year suggest turkey buffet dinner, cost \$25, and no subsidy.

Request board approval. Moved and Seconded. Approved.

- 3. Review revised 2017 schedule. Attached is copy. Request board approval. Lots of discussion on the issue of the guest day scramble. DN and CM to resolve. **Moved and Seconded. Approved.**
- 4. Like to host the maintenance and pro shop crew to a Thanksgiving luncheon. We have done this over the past couple of years. Request board approval for \$400. **Deferred till the next meeting.**
- 5. Stan's key person, Tony Aszate, that takes care of our catering events has done a great job over the years. As a thank you, like to give him \$200. Request board approval. **Deferred till the next meeting.**

B. PRESIDENT- ELECT LEONG

- 1. Holiday Party: Save the date notice has gone out (for 12/10/16). Menu has been decided and 9ers have designed and purchased most of the decorations. Entertainment has been confirmed. Newspaper article will be out in 2 weeks with envelopes. Cost looks like about \$40.
- 2. All Board positions for next year are nearly filled. We are filling 8 positions. Still looking for VP.
- 3. Fred Sun and I attended the annual BASA (Bay Area Seniors Association) meeting held at Round Hill Country Club. Representatives from the 24 clubs attended the meeting where topics of potential mutual interest were discussed and opportunities to establish more home and home events were available.

While there is no formal method for approving or enforcing topics discussed, there was an attempt to present ideas which would be implemented by others.

Some of the topics presented which appeared to have general agreement.

- 1 For home and home events, all rosters should be sent 48 hours prior to event and should include name, GHIN number and latest index for members attending. Effort to reduce load on the club pro setting up the foursomes.
- 2 Consistency of NO CHARGE for no shows
- 3 Use of modified Stableford as scoring system to speed up play; net bogey = 0, net par = 1, net birdie = 2, net eagle = 3, net double eagle = 5.
- 4 Use tee locations which create course lengths of 5700-6000 yards; one club indicated that they used gold tees (5400 yards) for all those >75 years old; Round Hill used silver tees which totaled 5700 yards.
- 5 Question was asked as to whether BASA clubs wanted to encourage additional clubs to join; apparently StoneRidge had found out about BASA and asked about joining. There was some interest but a number of folks commented that additional clubs might have difficulty getting enough home and homes due to already fully booked schedules
- 6 The BASA website is a "by invitation only" website so cannot really be found or stumbled across by just anyone. A small group, led by Tom McDowell of Orinda, will develop some low cost proposals focused on using WebX and not Yahoo groups; indicated that only 10/24 clubs had updated their club information

Other topics presented included:

- Changing all home and home events to afternoon only; deemed not possible by many
- A "Ryder" Cup point system for their players which gave points for participating in club events (H&H, tournaments, winning CTP, low gross, low net, etc).
- · Castlewood wanted to confirm for everyone of their "Dress Code" which included no cargo pants

General Observation:

The majority of the clubs had people attending who had participated in the BASA meeting a number of times; i.e., there was much more continuity than our club, at least in respect to the meeting

Fred Sun was approached by both Marin and Rio Vista about additional home and homes.

Final: Fred and I played golf in the afternoon from the silver tees; this was more enjoyable than the Blue Tees that were used for the home and home but still not easy. It was HOT!!

The Ambassadors have finished another great year of service.
