

**ROSSMOOR WOMEN'S 18 HOLE GOLF CLUB  
BOARD MEETING  
NOVEMBER 8, 2021**

**THE MEETING WAS CALLED TO ORDER AT 9:00 A.M. BY CAPTAIN, JANICE DAVIS AND WE WERE ONCE AGAIN ABLE TO MEET IN THE BUNKER ROOM.**

The minutes from the Board Meeting of September 13, 2021 were approved by *Margo* and seconded by *Toni*. The minutes from the Board Meeting of October 18, 2021 were approved by *Denise* and seconded by *Theresa*. Also, the minutes from the General Meeting of October 28, 2021 were approved by *Claudia* and seconded by *Teddi*.

**Treasurer:**

*Teddi* reported our current bank balance is \$14,646.46. She has more checks to deposit and there is \$379.54 outstanding. The Halloween Party had an excess of \$9.00. We have \$1,000 budgeted for the Holiday Luncheon and two more Sweeps to pay. The \$500 donated by Julia Lee, DDS for the Invitational was not used for the Mini Guest Day.

*Teddi* is checking with U. S. Bank about a separate account (which requires a new EIN#) to set aside funds that are carried over such as the Hole-in-One Fund.

**Co-Captain:**

*Daisy* is working with *Janice & Denise* re WGAN pin which is awarded each year to a deserving person.

## **Captain's Report:**

*Janice* thanked *Daisy & Denise* for their help organizing the calendar for next year. They all met with *Lily* at Recreation and were able to secure all the dates that we wanted. *Janice* had attended the Activities Council Meeting and they spoke about proper handling of meeting dates. Everything is going in electronically and should receive by the end of the year.

She talked about the \$400 budgeted for Xmas gifts and it was agreed to do the same as last year.

It was agreed that we would not have a Holiday lunch for the Board this year.

## **Tournaments:**

*Denise* spoke about our last tournament of the year which is the "Turkey Shoot" and traditionally the 'Orange Ball Tournament'. It was decided that we would check with *Mark* first and if need be, we would purchase new orange balls.

She brought up for discussion raising the budget due to more team events that have been requested. Changing payouts to include low gross and lowering maximum handicap to 36.

It was suggested that we have one ABCD team event monthly. We will need to look at the budget for next year to see if we are able to increase 'Sweeps'. It was suggested to raise Chip-Ins to \$1. Discussion followed. Janice said that we don't structure like the Men's Club and does not like making it mandatory. The majority of the players pay for Chip-Ins. More discussion.

It was agreed not to lower HDCP to 36 as it would eliminate a number of players. It was suggested to have a COMBO/Gold tees flight or pick-up after taking a "9"? *Theresa* suggested leaving it up to the Captain of that particular tournament whether to play to a 36 HDCP.

*Denise* also suggested having a practice round on May 12<sup>th</sup> at the Casual Guest Day before the Invitational?

### **Membership:**

*Toni* said that we have nine (9) new members bringing to a total of 111 if everyone renews. She is still missing about 28 renewals and will need to make some calls. She mentioned inviting them to her house for a little 'wine & cheese' and inviting them to play golf.

It was unanimous that we invite the recent 'new' members to the Holiday Lunch. *Toni* will do.

Also, she will update 'Duties for Membership' position.

**Rules:**

*Joyce* would like everyone to come up with a question or a situation for the Rules Seminar in August. Following are two questions that have come up recently:

- (1) Can one move the ball if there is a mark made by the grounds crew?  
It depends (see definition under GUR) if the grounds crew has created a hole (e.g., from removal of turf or for installation of a pipeline, etc.)\_, that is considered GUR even if it's not marked. Other damage (e.g., tractor rut) is not GUR unless it is marked.
- (2) Can one take relief from bare spots on the green? NO. (Rule 13.1c(2))

*Daisy* reported that Mark submitted an order for 41 items for 'Team' uniforms on Oct. 29.

*Laura* is working on posting 2022 match dates and matches on the 18er website.
