APPROVAL OF MINUTES OF DECEMBER MEETING

REPORTS OF OFFICERS

PRESIDENT SNYDER

A By-Laws change was submitted by Mike Wener and Brent Atkins aimed at modifying the By-Laws and improving communication. The current By-Laws specify that elections shall be held within 10 days of the Annual Meeting (Defined as the November Annual Meeting) and there shall be an election of officers (President, Secretary, President Elect and “Assistant Officers ...who may or may not be Board

Members”) The proposed By-Laws change would delete the 10 day requirement, eliminate single terms of service, and allow incumbents to step into a new role or to continue in their present role.. A motion to adopt the By-Laws change was entered by Bill Keeley and seconded by Mark Weiss. Discussion followed. Notably. Pat Iacullo asked when a President Elect would be named. Mike Wener commented that the By-Laws were clean in their intention. The vote was called and the changes passed unanimously by the Board. The change will be
