Meeting Notes:

07-10-23 Board Meeting Minutes to be corrected. Will be voted on at the next Board Meeting.

Captain's Report - Margo Dutton: Margo was absent. Toni Snyder acted in behalf.

<u>Co-Captain Report – Toni Snyder</u>: Co-captain has nothing to report and working on Open Day 8/24/2023!

Discussion Items:

<u>Treasurer, MaryJean Kidd</u>: MaryJean will review General Meeting notes and submit a report. The current 2023 Budget status and a report for each event were sent out for review (see accompanying). Administration costs for the website have increased as noted in the report. Recommendation made to use \$215 dues originally allocated to the Rules Seminar, which has been cancelled, for the Holiday Party and to use the \$100 dues originally allocated to Guest Days, but not spent, for the Holiday Party. Recommendation approved by the Board.

Nominating Committee: Margo and/or Daisy Soo Hoo will approach Marsha Jennings who may be available to lead the Committee. Myrna has expressed interest in being Treasurer. Some other names have been suggested for other positions. Need nominees for Social and Publicity committees. The Nominating Committee, once formed, will explore options. Suggestion was brought to ask the nominating committee to be clear of what the duties are for each position.

<u>Event: 9/7/23 Guest Day</u>: GHIN not required. There are no contests for this event (except a closest-to-the-pin). Laura will generate sign-ups.

Event: 10/03/23 Charity Event (with men). The men will do the food. Looking for a Chair (possibly Pat McSween). MaryJean might be willing to Chair if there is adequate help. MaryJean will spearhead a kickoff for this event (Laura will help). Need to verify if the 9ers are included (reportedly they were not included last year).

<u>2024 Budget:</u> The 2024 Budget was circulated to the Board (see accompanying). Dues are increasing to accommodate NCGA increase. This will need to be presented to membership during the October General Meeting. The Board moved to approve the 2024 Budget (motion to approve by Teddi Swanson, seconded by Robin Moreau).

<u>Schedule and Room Reservations</u>: Margo, Toni, Laura and MaryJean are working on the Schedule for 2024 – won't be final until Sept/Oct. Best to start reserving rooms soon – easier to give up space than add it later.

<u>Upcoming Events:</u> Toni reports that the Aug 24 Open Day is all set. Might need some volunteers. Daisy reports the Aug 30 EBTP event is set. There will be a meeting next week for the Aug 30 Cocktail Social. Toni is starting to coordinate the Halloween Bash and Denise is working on the Club Championship.

<u>Rules – Joyce McCann</u> (see also report below): Suggestion: Rules of Golf idea – on Thursdays, have a "Rule per Day" either on a board near registration or included on the score card. Joyce has a list of potential rules. Suggestion to possibly focus on rules that give an advantage. USGA has Rules 101 course, but it's not simple. Bag-tags with rules is another suggestion. Joyce and Denise will coordinate.

Discussion regarding co-sponsorship of the Rules Gala by all 3 clubs. MaryJean motioned to approve co-sponsorship provided the 18ers maintain ownership, Judy Moran seconded. The motion passes. Joyce to draft a memo to be sent out to each club. Need to coordinate rules used (putting out, etc.).

<u>Club Championship discussion</u>: Claudia brought up for discussion the idea of changing the Club Championship from a 3-day event to a 2-day event. Typically, there is no change in the eventual winner at the end of day 2 to the final winner. There are usually 10-13 field-followers who might be more likely to compete if it were just a 2-day event. The Tournament Chair is in charge of the Club Championship. Joyce suggests this should be a "special" event, not just another tournament. Per Toni, some other clubs hold a 3-day event for the Championship flight, but a 2-day event for other flights. Denise will discuss this topic with Jackie. There will be a lunch for the Championship event (makes it more formal).

<u>Publicity (Claudia Terry):</u> Claudia will look at updating the website photos – from ancient to current.

<u>Tournament Report (Denise Pratt):</u> Discussion of why we changed the number of Casual Guest Days. During COVID, the number of events changed. Trying now to resuscitate, but need volunteers to do more. There was discussion whether the 18ers want to join with the Couples Club to purchase glass cups for events. The Board decided not to join due to added responsibility, clean-up, replacement, etc. There are only 4 or 5 more Thursdays left in the season. There will be a 2-man best ball event and a game on Sept 14 that sounds confusing but isn't (and will be fun).

Golf Advisory (Robin Moreau): Hillside on #10 is slippery. If you don't have to, don't go down that hill. Go to the bottom of the bridge and come back around via the level areas. Robin discussed some upcoming proposed rate increases for next year, including the Resident Daily Rate from \$28 to \$30 on Dollar and \$14 to \$15 on Creekside. No change to Twilight rates. Guest lesson rates would increase from \$55 to \$60 per half hour (\$20 to \$25 for juniors). Resident lesson fee would remain the same. No proposed change to cart fees.

Website Administration:

The <u>rossmoorgolf.com</u> website is now supported by eWebServices. The site has been migrated to new servers and all malware, viruses, corrupted files and corrupted users have been removed. The service contract includes 24x7 site monitoring, backups and WordPress updates.

Website will be cleaned up to remove outdated information and links. The Tech Committee will be working with RMGC to create better alignment with regards to the website. Additionally, the Tech Committee is providing support for the Niners and the Hackers for website updates, etc.

Tournament Report: Denise Pratt.

Will review the games of the last few months of our season, including the Championship tournament in October.

Handicap Report: Laura Kim

Two emails have been sent out to the membership to post their score (June 24 and July 23). Members should be given a gold star because most are posting their non-Thursday play days at Rossmoor. Only two were given an additional notice to post. I will continue to monitor players through August (with Jacque).

When members register for the Club Championship, I will check compliance with the tournament rules and work with the Tournament and Rules Chair to address any issues *before* the tournament begins.

I will begin looking for a 2024 Handicap Chair to take over my responsibilities.

Rules Report - Joyce McCann

- 1. Formation of an Inter-Club Rules Committee (me, Dorothy Pierce (9ers), Barry Savnik (RMGC), directed by Mark Heptig to unify and coordinate Local Rules among 18ers, 9ers, and RMGC. We've had an introductory mtg with Mark. Next mtg August 21st.
- 2. Rules Gala 2.0.
 - a. When in August will we know if we have March 25th 2024 reserved?
 - b. Does the Board favor co-sponsorship of the Rules Gala by all 3 clubs? Would like to discuss this and the best way to pursue this further.
- 3. On-Course Rules classes.
 - a. Basic class. August 21^{st} class -3 sign-ups as of 8/8.
 - b. Bunker/Putting Green class -1^{st} class (July 31^{st}) was full with several on the waitlist. Waitlisted players were given the option of being pre-registered for the 2^{nd} class (August 28^{th}). As of 8/8, the 2^{nd} class is also full with 1 player on the waitlist.
 - c. For discussion: Plan for the remainder of the Season.
- 4. **For Discussion**: Should 18er policy require that all 18ers know the most basic Rules of Golf? Comment from MaryJean: IF this was a requirement, how would it be enforced? What if someone did not know the basic rules? How would that be approached?

East Bay Team Play (EBTP) Report - Daisy Soo Hoo / Karla Witte

Rossmoor hosted EBTP on July 27 and won two of our matches. Hiccup with room reservation in Event Center. Recreation Dept. doubled booked the room. Mark resolved issue and moved the 9ers to the Fairway Room. Need to ensure that the 18ers have history for the Event Center for our July 2024 date. Two more matches for the year: Aug 15 Round Hill and Aug. 30 Oakhurst. Rossmoor is currently tied in ninth place for gross points with Castlewood and ninth place for net. Planning an end of the year gathering on Friday, Sept. 29 for all members that participated in EBTP. Pat McSween has kindly offered to host event at her house.

<u>Past Captain Report</u> – Daisy Soo Hoo. Handicap trophy is being engraved and will be ready for pick up in a week.

Golf Advisory Report – Robin Moreau (for July and August)

Mark is pleased with the numbers of play considering the slow start this year. Good news is that EBMUD water was not used until June 15th.Normally opened in Feb so a 'good balance'.

He has capped the 'Resident Sponsored Guest' program at 70. He is making comparisons with fees at other golf courses and feels there will be necessary increases next year.

He would like to see a new range ball distribution machine and better water/filtration system meaning new water fountains such as the fitness center has.

Long range projects are re-lining the lake & replacing portions of the pump house in the next 5 years.

Maintenance now has its own stump grinding equipment.

They will continue with turf reduction and use mulching on fairways to conserve water. You may have noticed the hillside on #10.

Also new split rail fencing on #12 tee.
