Minutes: Vote to approve the 11-13-23 Board Meeting Minutes: Motion by Toni Snyder, Seconded by Teddi Swanson. The minutes are approved.

AGENDA ITEM DISCUSSION:

- #3 <u>Captain's Update</u>: Working on the Christmas Party. Agenda for the Christmas Event is under development. Will add to introduce new members.

MJ will initiate a Budget, Last year there were 69 guests – plan for around 75 for this one. Last year members were charged \$25 for the event + \$19 for food. Probably budget for \$30 fee plus \$22 for food this time.

Margo will create a Slide Show (similar to last year).

Jacque will be asked to make an appearance and say something.

Will probably need (5) tables: Rules, EBTP, Birdies/Eclectic, Tournaments, Golf Genius For HOLE-IN-ONE, will need a list of who has already paid (to avoid duplications).

Food: Lana will begin working on details. Possibly a Chinese Buffet. Will be providing beer and wine. Discussion was to shoot for around \$22 per person for food.

Other Business:

<u>NCGA Representative</u>: Claudia had originally agreed to take this roll but now has work conflicts. Myra Belfiore has expressed interest. The job description defines this position as being the main (only) contact between NCGA and our club and the person should be "fluent" in the club. Myra has been on the Board in the past. The Board encouraged that all communication received from NCGA by this representative should be forwarded to the Board. This position is not a Board position. No vote was necessary.

<u>Sponsored Guests</u>: There is an approved list for sponsored guests that is maintained at the Pro Shop and players must be on the approved list to be eligible. The course only takes 75 total and we are close or at that number now. Coordination of this list needs help. Teddi will ask the Pro Shop to send a list of all current sponsored guests. Teddi has asked the Pro Shop to get new application forms.
