## 3. Captain's update, updates to upcoming tournaments & other items – Toni Snyder:

Invitational Tournament: (Denise and Mary Ann): Theme is "Rossmoor Goes to the Olympics". Planning is well underway. Food (Stan), games, snacks, prizes are in various stages of finalization. Will need some more volunteers. Mark will monitor the putting and chipping events. Event will be max. 120 players, as of today there are approx. 74 signed up (need an Eblast to get more sign-ups). Currently have (8) hole sponsors. Budget was discussed and appears to be acceptable. Play will be from the Combo tees with 2 net best-balls scored. There will be (2) closest-to-the-pin awards (members & guests). There will be an option to purchase mulligans and putts. Considering adding an option at a Par 5 to buy a free drop at a pre-determined location with a \$5 donation going to charity (will need someone to monitor / collect \$). No longest drive or most accurate drive contests.

Classic Tournament: Toni and Lana are working on it.

<u>Handicap Tournament</u>: MJ and Laura volunteered to chair and will initiate a kick-off meeting, hoping to encourage more volunteers to assist. Needs to get into Golf Genius soon

Blue & White Tournament: Toni is chair. Similar to last year. Maybe Brats & Beer or BBQ'd hamburgers by Stan.

Request by club member to add a reward for Eagles. There is currently a \$100 prize for members who participate in the Hole-In-One fund (cost is \$5/year). Recommendation is to add a prize for Eagles. There is currently approx. \$1100 in the fund and there are typically approx. (5) hole-in-one winners per year. A decision whether to implement was tabled while MJ analyzes the potential impact. If implemented, it will be an option for next year.

<u>Social Membership</u>: Discussion was to allow former Rossmoor residents to sign up as Social Members to be able to attend events. The Board decided to modify membership next year to allow this and to send notification to past members to remind them and encourage them to take up this option.

Nominating Committee: Need to start recruiting and need someone to spearhead!

#### **Membership Report: – Teddi Swanson**

## **Technical Committee Report Out:** Laura Kim / MJ Kidd

- Happy to announce that Daisy Soo Hoo passed the USGA Handicap test which officially makes her the 2024 18ers Handicap Chair. Congratulations Daisy! I am officially retired.
- Updated Membership Directory sent out on May 4 to include 6 new members since the first publication in January. Updated booklets were given to the Pro Shop.
- Over the past two months, website support was provided to the Happy Hackers and Niners to update their respective websites with current information for 2024. Specific areas were addressed and updated: membership, board members, event schedules, and outdated documents. There has also been Golf Genius training support for the Hackers since their technical support person resigned.

Not related to the Tech Committee, but an informational item on 18er collaborative support:

- RMGC recently hosted the Cinco de Mayo tournament on May 3. Pat McSween and Laura Kim serve on the RMGC Tournament Committee led by John McDonnell. Toni Snyder graciously volunteered her time to help set up the event. 120 registered and Havana was selected as the caterer. Corn Hole and Sticky Golf games were set up for enjoyment after golf. One comment was to do this again for 4th of July. Haven't heard a response yet.

# **Tournament Report: Marsha Jennings**

- The second Charm is in the books with each of the winners has had \$15 credited to her account.
- I think we need to cancel the June 27 picnic area. It is just a Thursday play day. I'm not in favor of any picnic area as they have to microphone service. <u>Board decision</u>: June 27 picnic area will be cancelled. It turns out that use of the picnic area for future events is not overly complicated and is an available option.

#### Topic up for discussion:

From Marsha: I would like to rethink our policy of no follow the field. If someone is unable to play both days of the next tournaments there is no play day until June 27. I also don't believe we need to make people play in a tournament if they really don't want to play. To me it doesn't really matter how many players are participating in a tournament. We need to let the members decide if they want to play or are unable to play in the event not go for amount of players playing in the tournament.

<u>Board discussion and decision</u>: MaryJean motioned, Mirna seconded and the motion passed by a unanimous vote that the decision to remove the "Follow-The-Field" option at tournaments will be rescinded. The Follow-The-Field option will remain an option at future tournaments.

## Rules Report - Joyce McCann

- 1. On-Course Rules Classes.
  - a. There were 8 attendees in April classes 4 in Part 1 and 4 in Part 2. Next classes will be offered on May 20 (Part 1) and June 17 (Part 2).
- 2. <u>Preferred Lies</u>. We will keep the Preferred Lies Local Rule in place until further notice. I don't think a blast is necessary.
- 3. <u>18er policy for resolving rules issues</u>. This was discussed at the last Board Mtg and the blast below was sent to the membership. It was also decided at the Mtg that, since this is a new policy, it should be written down somewhere. <u>Board decision</u>: MJ will draft and distribute for comment and for official implementation.
  - "Rules issues arise during both Stroke and Match play that players are unable to resolve on their own. The Rules of Golf state that, in these cases, the ruling should be

made by the "Tournament Committee". The 18ers Tournament Committee is comprised of the Tournament, Rules, and Handicap Chairs. If Rules issues arise during play that cannot be resolved by players, the following procedure should be followed. First, players should bring the Rules question to the 18ers liaison professional in the pro shop as soon as possible. If the ruling is straightforward, the professional will make the ruling and then notify the 18er Rules Chair about the incident. The Rules Chair will inform the Tournament Chair and the Handicap Chair. If the ruling is not straightforward, the liaison professional will notify the 18er Rules Chair and the ruling will be made by the Tournament Committee."

# East Bay Team Play (EBTP) Report - Karla Witte + Pat McSween

The Rossmoor host event on May 2 was a resounding success, and our dedicated volunteers truly outdid themselves. Crow Canyon was eager to learn from our triumph.
